# Position of the course

This advanced course aims at developing insight into the history of cultural currents in European civilisation and the place of music within those developments. The course should lead to a broad cultural understanding. Students should learn to understand cultural phenomena within their context. In this course, this ability is trained through a focus on one particular art form: music. The course should lead, finally, to cultural understanding and insight into the aesthetic qualities of music.

# Contents

Music history between 1780 and 1940. The course focuses on developments since the late 18th century until the generation of the *fin de siècle*.

#### Initial competences

To have successfully completed the course "Music History to 1750 or to have acquired the necessary background by other means.

#### **Final competences**

- 1 development of auditory memory through the recognition of music fragments on hearing.
- 2 Knowledge of music historical developments and their relation to cultural history
- 3 development of an aesthetic frame of reference concerning the music of the eighteenth and nineteenth centuries
- 4 knowledge of music historical terminology
- 5 Insight in historical processes and the methodology of cultural historical research
