Work Placement

Position of the course

The purpose of this course is to introduce students to the context in which they, after being graduated, will be able to valorize their acquired knowledge and skills from the master's programme Linguistics and Literature (Historical Perspectives). During the work placement, the students will become acquainted with several aspects of this context which cannot be transferred by theoretical education. Furthermore, the work placement will incite the student to reflect critically on their study programme.

Contents

Preferably, the work place fits in with the study track of the student. It comprises 200 hours (25 working days). The student can choose between a research work placement pur sang, or a professional work placement which includes a research component:

- A *research work placement* can be done in a research group connected with Ghent University or in an external institution which offers such work placements (see list Stagegids). The research assignment is set in consultation with the work placement tutor, so the work achieved would help the institution. In a research work placement, the student will carry out tasks which prepare the actual research, in order to develop skills that will help them to do scientific research. More specifically, this includes activities such as the composing of bibliographies, the registering and collecting of data or cases, or the preparing of scientific colloquia. This work can form the basis of the research the student has to do for his/her master's thesis, but this is not compulsory. If there is a link between the work placement and the master's thesis, it is important that the work placement and the master's thesis generate their own output.
- In a *professional work placement*, the student works within the normal routine of a cultural institution (see list Stagegids). In consultation with the coordinator of the master's programme Linguistics and Literature (Historical Perspectives) and the tutor the assignments are clearly set at the beginning of the work placement. A research assignment needs however always to be part of the range of duties. This assignment will also be set in consultation with the tutor, the

coordinator, and the other persons in charge within this course. So, within this kind of work placement, the student has two distinct roles, a participating one and a researching one:

- participating component (50-80% of the work placement; target figure: 50-60%): participating in the daily routine
- research component (20-50% of the work placement; target figure: 40-50%) independently doing a small, but full research; can result in a finished product - a mini-exhibition, an app, a (contribution to a) publication ... - or could stay a concept. A written report is to be added in the portfolio.

Initial competences

Disposing of profound (theoretical) knowledge, methodological skills and a critical ability within the field of the work placement, and in line with the final attainment levels of the Bachelor of Arts in Linguistics and Literature.

Final competences

- 1 Getting acquainted with the broader professional field, in order to be able to choose a suiting career, in function of own interests and ambitions.
- 2 Being able to act professionally and deontologically.
- 3 Being able to implement knowledge and skills.
- 4 Being able to integrate into a team and participating in its daily activities.
- 5 Being able to handle feedback in a constructive way.
- 6 Being able to answer research questions in a scientifically sound way, which is also relevant for the practice.
- 7 Being able to report on the work that has been done in a structured way, orally as well as in writing.
- 8 Being able to reflect critically on one's own actions, and on the learning process within a professional environment.
- 9 Being able to reflect on the organisation, the activity and the finances of an institution.

Work placement: independent learning situation of experiential learning in a professional practice setting during a period of 200 hrs; the preparation and the writing of the report are designed to be finished in 100 hrs. Included in the report are (at least) two meetings with the UGhent-coordinator: one introductory meeting (= discussion of the job responsibilities and expectations) and an interim evaluative meeting (= discussion and evaluation of the progression). Participating in those two talks is compulsory, but will not be quoted. The final talk - see below - will be.

Extra information on the examination methods

- 1) Participation = taking part in the three compulsory meetings (see Details didactische werkvormen)
- 2) Assignment: see guidelines in the Stagegids
- 3) Professional practice: final evaluation by the tutor on the basis of the evaluation document with set criteria (see Stagegids)
- 4) Oral assessment = final meeting, explanation of the report

Calculation of the examination mark

Non-periodical evaluation (100%): the final score is determined by the tutor on the basis of the professional practice (30%) and the handed in assignment (70%). The latter includes the final internship interview with the supervisors of the course unit. If one does not take part without a valuable reason in one of the evaluation forms (1-4), then one can not pass and will, if his or her total would be 10/20 or more, get a final score of 9/20.
