### Position of the course

This introductory course gives students an insight into the modern social and political realities in South Asia.

### Contents

This course aims to provide the students with the necessary background to interpret contemporary South Asia through a social scientific lense. By focussing on a number of key issues (e.g. urbanity, caste, democracy, violence, gender) this introductory course aims to provide the students with points of reference to gain insights in the political, social and economic realities of South Asia. South Asia is understood in this course to be a historical formation against which the contemporary dynamics have to be understood. The focus will be on what used to be British India: Bangladesh, India and Pakistan.

#### **Teaching methods**

Seminar, Lecture

#### **Extra information on the teaching methods**

After an introductory session, this course will be organized around a number of big themes (eg. caste politics, violence and democracy, gender relations, migration, nationalism). Most themes will be covered in two classes. The first takes the form of an ex-cathedra lecture, which provides students with an overview of the social-scientific state of the art regarding the specific theme, its historical background and its importance in contemporary south Asia. The second session is a seminar consisting of an introduction and a discussion of the theme based on a selection of readings or visual materials. Students work through the materials for these seminar sessions beforehand. Materials can include social-scientific literature (articles or book chapters), (historical) documents, media-fragments, documentaries, etc. This course is organized on-campus, but students can join online if necessary. In such cases the student contacts the lecturer-in-charge beforehand.

20% of the final grades are given for participation. Throughout the semester, students are expected to create at least four forum posts using relevant newspaper articles, videoclips, or social media content, and frame these within the context of the topics discussed in class.
