Position of the course

This bachelor-level course in Museum Studies and Art Policy provides a comprehensive exploration of museum histories and development both internationally and in Belgium, delving into the integration of museums with music, theatre, and performance arts. Students will engage with foundational museum theories, apply these during site visits, and enhance their understanding through practical assignments like writing a reflective paper and creating a funding application under Flemish art policy. Additionally, the course offers direct interaction with professionals in the contemporary museum field, addressing critical issues museum face today such as decolonialility, sustainability, and digital transformation.

Exchange students may take up this course unit, for which no prior knowledge of

Dutch is required.

Contents

This course is structured around four key components, designed to provide a comprehensive understanding of museum studies and art policy: 1 Historical and International Perspectives:

- Acquire knowledge of the historical evolution and development of museums both internationally and within Belgium.
- Explore the interdisciplinary connections between museums and various forms of art such as music, theatre, and performance.
- 2 Museum Theory and Practical Application:
 - Study foundational museum theories.
 - Write an analytical paper that applies museum theory to a museum site visit.
- 3 Flemish Art Policy and Practical Engagement:
 - Develop a thorough understanding of Flemish art policy.
 - Collaboratively design a funding application for the Arts Decree, integrating course learnings and practical application of art policy.
- 4 Professional Integration and Networking:
- Engage directly with professionals currently active in the museum field.

Initial competences

Intrinsic interest museums and art policy. No previous museum studies or art policy knowledge required. OZVI is highly recommend, or a similar class that has taught fundamental writing skills (how to craft an argument, create an outline, cite sources).

Final competences

- 1 Acquire basic knowledge of historical developments regarding socio-cultural histories of museums, exhibitions, collecting, and curating
- 2 Be able to critically analyze and evaluate how the "museum effect" works
- 3 Work indvidually to write a clear, structured, and well-argued critical essay on a topic related to the museum excursion
- 4 Reflect critically on how dance, theatre, music, and performance intersect with museums
- 5 Be able to discuss the societal challenges facing museums today
- 6 Learn from museum professionals: formulate questions for the speaker
- 7 Demonstrate basic knowledge of arts and cultural policies in Flanders
- 8 Work in a team to create an art policy plan based on Flemish guidelines
