#### Position of the course

This course is one of the eighteen research seminars that constitute the core of the master programme. Depending on initial qualifications, students enrol for three or five such research seminars.

#### Contents

The seminar consists of a series of minimally 5 meetings spread over the whole academic year, where students, guided by a lecturer or tutor, discuss and exchange ideas related to prominent themes in contemporary continental philosophy. Each meeting is coordinated by one of the tutors (who may be assisted by a post-doc or a PhD student enrolled for the seminar). The coordinator makes sure that there is a list of relevant literature made available in the beginning of the academic year. Meetings are organized in Ghent, on Friday afternoon, from 2 PM till 4.30/5 PM.

The aim of this seminar is to incite beginning researchers to set up innovating and articulate academic research up to date with current literature, and to give shape to their thought in one or more papers ready for submission to a peer reviewed journal. Moreover, the students will be assisted in preparing a research proposal to be submitted as a PhD application. The aim is eventually to attract and (co-) supervise doctoral students who do active research on contemporary continental philosophy, nationally and internationally. The assessment is continuous and end-of-term, and concerns the participation during the meetings, the preparation of the paper(s), the contribution to a research proposal, and the final paper(s).
