Position of the course

This course introduces students to the concept of "belgitude", as well as intra- and intercultural literary traditions in the French and Dutch areas of Belgium. Attention is paid to social and political history, literary traditions, recent developments of literary cultures, and the translinguistic context. Engagement with linguistic and cultural convergences and divergences within Belgian literature.

Contents

- 1. Meaning of the term "belgitude", with attention to the terminological history of the concept
- 2. Social and political aspects of Belgian language cultures, with particular attention to contact between Dutch and French
- 3. Overview of developments in the literary culture of Belgium (nineteenth, twentieth and twenty-first centuries)
- 4. Current intercultural connections: neerlandophone and francophone collaborations and Belgian cultural traditions
- 5. Discussion of authors and literary texts in Belgian literature, with particular attention to cross-fertilization between Dutch and French-language literature. Afro-Belgian literature is also discussed.
- 6. From a comparative perspective: literary-institutional collaborations, intertextuality, reception and imagology, cross-linguistic cultural production

Initial competences

Basic knowledge of literary and cultural-historical concepts within Dutch-language and French-language literature. Literary competences acquired during bachelor study. Interest in comparative literature and intranational (Belgian) multilingual literary discourses.

Sufficient knowledge of Dutch and French.

- 1 Insight into interactions between the Dutch-language and French-language literatures of Belgium.
- 2 Insight into the socio-historical context within which Belgian literature developed and continues to function.
