# Teaching languages

#### Keywords

Akkadian, Old Babylonian, Cuneiform Writing

#### Position of the course

This introductory course aims at familiarizing the students with the Old-Babylonian language and cuneiform writing on a scientific basis. Old-Babylonian is the South-Mesopotamian dialect of Akkadian, the oldest attested Semitic language, and was spoken and written during the first half of the 2nd millennium BC. Special attention will be devoted to the origin, evolution and basic principles of cuneiform writing, the linguistic structure of Old-Babylonian within the evolution of Akkadian and the Semitic languages as well as the cultural history of Mesopotamia in the 2nd millennium BC. The course gives the student a basic passive (translation) and active (theme) language knowledge and the attitudes necessary for the academic study of Old-Babylonian (insight, accuracy and motivation).

#### Contents

The grammar of Old-Babylonian is taught through theoretical lectures and guided exercises (seminars) from the standpoint of the scientific study of the language. Apart from the grammar, the student will learn a basic vocabulary (ca. 300 words) and a basic corpus of ca. 200 cuneiform signs. This will allow the student to understand and translate sentences and simple texts (both from Old-Babylonian into Dutch and from Dutch into Old-Babylonian) in transcription and to read sentences and simple texts in cuneiform writing. The student learns to study the language in a systematic and scientific way: with insight, on a theoretical basis and with much stress on basic structures. In this way, the foundations are laid to elaborate this theoretical knowledge autonomously. As Old-Babylonian is a member of the Semitic language family, the student is familiarized with the characteristics of this family. Parts of this is done through lectures, after which much attention is paid to master the acquired knowledge (grammar, vocabulary and cuneiform writing) by practice in seminars.

#### Final competences

- 1 To have an insight into the structure of Old-Babylonian and to have a basic knowledge of morphology and syntax of Old-Babylonian.
- 2 To have an insight in the origin, evolution and use of the cuneiform writing system.

- 3 To have a grammatical knowledge of Old-Babylonian that has a strong theoretical fundament and can be put to practice.
- 4 To know the basic vocabulary of Old-Babylonian and the basic corpus of cuneiform signs.
- 5 To be able to transliterate, transcribe, analyse grammatically and translate autonomously and without help Old-Babylonian sentences and simple text in cuneiform script.

The written examination comprises questions concerning the basic structures, practical implementations of the grammar, a translation (Old-Babylonian – Dutch; in transcription as well as in cuneiform writing) and a theme (Dutch – Old-Babylonian; in transcription).

#### Calculation of the examination mark

- Translation and grammatical analysis Old-Babylonian Dutch in transcription: 50%
- Transliteration, transcription, translation and grammatical analysis Old-Babylonian Dutch in cuneiform writing: 25%
- Theme Dutch Old-Babylonian: 25%
