Position of the course

The course intends to give students the historical and theoretical background necessary to engage

knowledgeably and critically in contemporary heritage debates. This class examines the history/histories of heritage, the rise of heritage institutions internationally and in Flanders, and current heritage debates. Through targeted case studies, the course covers issues related to immovable, movable, tangible and intangible heritage. The focus will be national and international. Issues revolving around problematic and contested heritage, debates regarding decolonization of the public space and of institutions, and restoration/adaptive reuse of heritage buildings will be addressed.

Contents

- Differentiating between heritage and history
- History/histories of heritage from the 19th century until today
- The institutionalization of heritage (UNESCO, charters)
- Heritage in Flanders: practices, policies, institutions

- Problematic heritage: looting, appropriation, restitution, decolonization, gender
- Identifying the Authorized Heritage Debate and being able to apply it as a critical framework
- Heritage and the Built World: preservation, restoration, conservation, issues of authenticity
- Intangible heritage: preservation of music, language, dance, traditions, perfromance, rituals...

Specific cases of movable, immovable, tangible and intangible heritage will be studied, critically evaluated, and

discussed. Class participation is strongly encouraged. Excursions will be planned, when possible.

Initial competences

Previous knowledge of architectural history and theory is recommended, as is previous knowledge about the histories and theories of museums and art institutions.

Final competences

- 1 Gain an understanding of the history/histories of heritage from the 19th century until today
- 2 Gain familiarity with international and Flemish heritage institutions, policies, decrees, charters, and conventions
- 3 Understand key concepts in critical heritage studies such as authenticity, memory, decolonization, restitution, preservation, heritage vs. history, gender
- 4 Understand key issues in current debates within immovable heritage, notably issues around adaptive reuse, heritage building restorations and renovations
- 5 Understand the institutions and processes of intangible heritage
