### Keywords

Tangible and intangible heritage, material and immaterial heritage, restauration and conservation, international treaties and conventions, heritage decrees and heritage policies, (illegal and illicit) trade in culture goods, debates around culture goods, cultural appropriation, *Authorized Heritage Discourse*, reception and restitution of culture goods.

### Position of the course

The course is an introductory course that provides students with insights in historical and theoretical backgrounds, definitions and conventions related to heritage. It does so by presenting several heritage case studies that are analyzed and discussed throughout the lectures; on the national as well as the international level. Special care and attention is given to elements regarding restauration and conservation of monuments and sites, issues of problematic and contested heritage, the *Authorized Heritage Discourse* and the current debates about the role of heritage within society. Equal attention is given to tangible and intangible heritage. In doing so, the course intends to provide students with methods to engage actively with heritage in all its forms.

### Contents

- Ideas about heritage: from the 19th century to the present
- Heritage and the built world: preservation, restauration and conservation of heritage, authenticity, ...

- Heritage international: UNESCO, charters, conventions, ...
  - Heritage Flanders: policies, decrees, institutions, ...
  - Contested heritage: illegal and illicit trade, cultural appropriation, restitution and looting, ...
  - *Authorized Heritage Discourse*, heritage and communities, critical heritage, ...
  - Intangible heritage: (evolving) traditions, customs, rituals, ...
- Lecture attendance, extra muros activities and assignment(s) are an integral part of this course. Presence in the class is strongly encouraged.

### Initial competences

No specific previous knowledge is required. A strong interest in art, culture, architecture, archaeology, society and heritage in general are greatly encouraged; in its tangible as well as its intangible form.

### Final competences

- 1 Gain an understanding of the history/histories, definitions and theories regarding heritage from the 19th century until today
- 2 Gain familiarity with international charters and conventions and with the workings of Flemish heritage institutions, the Flemish heritage decree for cultural heritage and immovable heritage
- 3 Understand key concepts in critical heritage studies and apply these conformingly
- 4 Be knowledgeable about current heritage debates and be capable of critically reflecting upon specific heritage cases
- 5 Be knowledgeable about the changing role of heritage within society

This class consists of lectures, supplemented by occasional guest lectures and an international excursion. Participation during the discussion of heritage case studies is stimulated via open questions. Class attendance is strongly encouraged. Preceding each lecture a pptx and reading assignments will be uploaded via UFORA. Each pptx will be provided by blank space to add your personal notes to. Lectures will not be recorded. There is no written course: your own notes taken during class, along with the weekly provided pptx and reading assignments are the core of this course. This course also has a mandatory international three-day excursion to Paris, that come with assignments.
