### Position of the course

This course offers students a historical overview of textiles and fashion from antiquity to the present, with a global perspective on the development of materials, techniques, and styles. Students will engage with key themes such as trade, labor, colonialism, and sustainability, gaining insight into how textiles and fashion have shaped and been shaped by social, cultural, and political forces. By the end of the course, students will have acquired a specialized vocabulary and critical tools to analyze textile and fashion objects in their material and historical contexts. Exchange students may take up this course unit, for which no prior knowledge of Dutch is required.

### Contents

- Acquire knowledge of the histories of textiles and fashion from ancient civilizations to the present, with attention to materials, techniques, style, and global trade networks.
- Develop a vocabulary for analyzing textile and fashion objects, including fibers, weaves, dyeing, embroidery, printing, sewing, and finishing techniques.
- Analyze textiles and fashion through critical frameworks of class, race, gender, and colonialism, with a focus on both historical and contemporary contexts.

### Initial competences

No previous knowledge or expertise of fashion or textiles is required.

### Final competences

- 1 Identify key fabrics (cotton, wool, silk, linen, synthetic fibers) and recognize techniques such as weaving, knitting, printing, embroidery, and dyeing.
- 2 Discuss the global histories of textiles and fashion from ancient civilizations, including Egypt, to the present day.

- 3 Accurately situate fashionable silhouettes within their historical periods, from circa 1500 to today.
- 4 Critically analyze textiles and fashion through the lenses of class, race, gender, and colonialism.
- 5 Evaluate the use and significance of visual, material, and textual sources in constructing fashion and textile histories.

#### **Extra information on the teaching methods**

This course combines lectures, guest lectures by fashion and museum professionals, close readings of historical and theoretical texts, and site visits to museums, collections, and workshops. Students are encouraged to actively participate in discussions that connect materials and techniques to broader social, cultural, and historical themes. Attendance is strongly recommended, as in-class engagement and peer dialogue are essential to developing the analytical skills emphasized in the course.
