Position of the course

This class provides students with a historical overview of textiles and fashion from Ancient Greece to the present, offering a comprehensive global perspective on the evolution of techniques, materials, and style. By the end, students will be equipped with the necessary vocabulary and analytical tools to meticulously examine and understand various aspects of textile and fashion objects.

Exchange students may take up this course unit, for which no prior knowledge of Dutch is required.

Contents

1. Acquire knowledge about the history of techniques, materials, and style of textiles and fashion from Ancient Greece until today from a global perspective
2. Gain the vocabulary to analyze textile and fashion objects: fibers, weaves, embroidery, printing, sewing, etc.
3. Analyze fashion and textiles from the position of class, race, and gender.

Initial competences

No previous knowledge or expertise of fashion or textiles required.

Final competences

- 1 Be able to identify different fabrics (cotton, wool, silk, linen, synthetics) and techniques (weaves, knits, prints, embroidery, etc).
- 2 Be able to discuss the global histories of textiles and fashion from Ancient Egypt until today
- 3 Be able to identify the date of a fashionable silhouette, c. 1500 until today
- 4 Be able to critically examine textile and fashion through the lenses of class, race, and gender
- 5 Be able to judge the value of using visual, material, and textual sources for fashion and textile histories
