Position of the course

Introductory course where students get an overview of Western performing arts from a culture historical perspective

Contents

This lecture-course examines the history of theater in the West from the origins of Western theater in Ancient Greece to 1850. It focuses on the history of performance practices in the West. Theater history is understood here as a form of cultural history, treating historical changes in acting, scenography, theater architecture or costuming from their geographic and socio-cultural contexts. Attention is paid not only to text theater (Sophocles, Shakespeare, Vondel, Racine, Goethe, ...), but equally to other genres and theatrical forms such as Roman spectacle culture, tableaux vivants and Joyous Entries in the late Middle Ages and Renaissance, opera and court ballet in the seventeenth century, or new visual techniques (panorama and diorama) that will steer the theatrical experience in different directions from the late eighteenth- and early nineteenth centuries onward. An important aspect here is how people thought about the performing arts in a given period: what were the poetic and theoretical views of what theater, dance or opera should be, and how can we interpret the changes in those views? Although the focus here is on Western theater history, it will address critical questions concerning gender, colonialism and the theatrical representation of the other. The course concludes with a three-day excursion to Paris.
