Position of the course

In-depth course in which students independently engage in research/collaborate in a research project and reflect on its valorisation. Through their choice of one of the modules offered, students either choose to further specialise in their previously chosen field of specialisation or expand it, possibly even inter- or transdisciplinary.

Contents

Through the division into modules, there is a choice of five, annually changing topics in line with the expertise and any ongoing research projects of the lecturers involved. These are generally situated in the fields of early modern art, art and interior 1750-1950, fashion and textiles, music history and theatre history, or the interfaces between them.

Certain modules may possibly be taught in English; specific information about this will be communicated via Ufora. In Research Seminar I or II, students preferentially choose the module of their supervisor or the most closely related field or topic (deviation from this is possible with good motivation or for language reasons).

Initial competences

Possess specialised research competences in art history, either acquired through

the course units Research Skills I and II and the Bachelor's thesis in the Bachelor's degree programme in Art History, or through equivalent courses.

Final competences

- 1 Possess advanced knowledge of specific aspects of art, interior design, fashion, music or theatre history.
- 2 Be able to look up historical and contemporary studies on specific aspects of the history of art, interior design, fashion, music or theatre, incorporate them into one's own research, and present them.
- 3 Be able to carry out independent and group research on specific aspects of art, interior, fashion, textile, music or theatre history.
- 4 Be able to devise and develop a concept for making the research results public using a specific format.

Teaching methods

Group work, Seminar, Excursion, Lecture, Practical, Independent work, Peer teaching

- Lecture: lectures and/or guest lectures on the specific subject covered
- Seminar: work sessions with assignments
- Independent work: independent processing of e.g. reading assignments; feedback on own project
- Research project: scientific research with a view to a paper/ article/... and its public valorisation
- Excursion: guided and/or individual visit/participation in one or several locations/ exhibitions/ collections/ study days/...
- Peer teaching: presentation of research results to the group and providing feedback to other students
- Group work: collaboration for heuristics, concept, and/or public elaboration of research results
- Practical: hands-on exercises in a professional context, research in libraries, archives, museums, documentation and research centres
