## Position of the course

This advanced course introduces students to the genre of the short story and to the major aesthetics and poetics of Spanish-American narrative of the 20th and 21th century.

Exchange students can take this course. No knowledge of Dutch is required.

## Contents

This course deals with the short story in Spanish-American literature of the 20th and 21st centuries.

After a theoretical introduction on the features of the genre, a selection of short stories (which can change every year) will be analyzed, both by writers who belong to the canon (Juan Rulfo, Julio Ramón Ribeyro, Julio Cortázar, Silvina Ocampo...) and by lesser known contemporary authors. Different aesthetics are considered (realism, the fantastic, magical realism, testimony, experimentation...), as well as specific authorial poetics, different narrative perspectives (e.g. the child narrator)

and different critical paradigms. The stories are always framed within their context. The course also has a diachronic dimension and pays attention to well-defined variants such as the "microcuento".

This course also includes a number of interactive practical sessions during which specific aspects of the course (reading and analytical skills) are further explored using a selection of stories written by the Chilean author Roberto Bolaño.

#### Initial competences

- To have completed the courses "Spanish language proficiency" or to have acquired a sufficient language ability by other means (level B2).
- To have completed the courses "History and Culture of the Spanish-speaking World" annd "Spanish-American Literature: overview" or to have acquired the necessary knowledge by other means.
- To be familiar with text analysis.

#### Final competences

- 1 To have acquired thorough knowledge of the major poetics, movements and concepts of Spanish American literature of the 20th and 21st centuries.
- 2 To have acquired the ability to understand and intepret 20th and 21st-century Spanish-American short stories.
- 3 To be able to orally and in writing report on modern and contemporary Hispano-American literature in advanced Spanish, with or without the use of GEN-Al tools. The latter should be used responsibly and their usage should be clearly indicated
- 4 To have acquired advanced mastery of Spanish, including fluent speaking ability.
- 5 To have acquired the ability to apply literary paradigms, analytical methods and interpretive techniques.
- 6 To have acquired the ability to explain a literary or cultural subject in a critical way and in an academically responsible form.
- 7 To have acquired a strong awareness of language and its role in human interactions and cultural production.
- 8 To have acquired the ability to think analytically about cultural, historical and literary problems.
- 9 To show intellectual curiosity and a lifelong commitment to learning.
- 10 To have acquired the ability to report orally and in writing in Spanish to both specialists and a broader audience
- 11 To be able to collect and contextualize both analog and digital sources of information in a structured manner. To be capable of critically assessing these sources for relevance, reliability, and validity.

The course is taught on campus. In addition to the lecture sessions in one group, each consisting of two teaching blocks, about five practical sessions, each consisting of one teaching block, are organized into two groups, covering exercises in close reading and the preparation of the presentations.

The lectures are recorded and the recordings are made available on Ufora. This course assumes the responsible use of generative artificial intelligence (GAI). During the

Assessment form

Examen: periodic evaluation: oral exam with written preparation. In the exam, alongside knowledge questions, mainly insight-based questions are asked. Students can be examined on their ability to analyze passages from the texts studied as well as from new texts.

Non-periodic evaluation:

Participation: attending the lectures and the seminar is mandatory. Active preparation is expected from the students, which involves preparation and contribution during the classes (reading primary texts, posting questions on Ufora, participating in discussions during class). If Al is used, this must be explicitly indicated. This part of the evaluation can not be repeated in the second examination. Unjustified absence during the lectures and the seminar sessions will result in a lower grade.

Presentation: students will deliver a presentation. This part of the evaluation cannot be retaken in the second examination if deemed insufficient.

Students may be asked to attend guest lectures and/or extracurricular activities.

Students who do not take part in the assessment of one or more parts of the course evaluation cannot pass the course. Should the average mark be higher than 10/20, the final mark will be reduced to the highest non-pass mark (= 9).

The evaluation takes into account the student's language skills.
