Teaching languages

German, literary studies, 20th and 21st century literature, short historical survey of German literature, model analyses, prose, poetry, drama

Position of the course

Beginning students have little or no knowledge of German literature, and many of them have little or no experience with courses taught in German. The aim of this basic course is to familiarise the students with the most important tendencies in German literature, with a first set of techniques and methods of literary analysis and with historical and thematic aspects of 20th and 21st Century German literature.

This course can be taken up by exchange students.

Contents

In this course unit, you will familiarize yourself with the basic questions of literary practice since the beginning of the 20th century and the ways in which to analyze and interpret literary texts (prose, poetry and drama) from this period. We focus on the major canonical authors, such as Kafka, Brecht, Rilke, Grass, Bachmann and Thomas Mann (we make an adapted selection

each year), but we also make room for more recent and sometimes less well-known authors. In specific case studies, you will learn about the big questions of the literary imagination of this time: what if we begin to experience language in a drastically different manner, what if warfare takes on industrial proportions, what if the past remains unprocessed, what if individual and collective forms of living are transforming, what if the future seems uncertain? All of these themes are addressed in specific ways in German-language literature of the 20th and 21st centuries. The lecturer will show you how he arrives at a thorough analysis of the selected texts, explaining not only the form and content of the texts, but also their historical background, genesis and reception; as a student, you will try to develop your proper thoughts on the matter and, where possible, participate in discussions, developing your own informed interpretation of the texts.

In the exercise section or "Tutorium" (practicum and guided self-study), you will work through a series of short writing exercises, practicing basic literary skills (including with digital tools); in this way, you will notice if you are making the desired progress and can prepare for the exam. Together, these exercises form your portfolio. You can get feedback on these exercises afterwards from one of the lecturers. The Tutorium normally also includes a guided library visit. Outside the lessons, we offer you a leisurely stroll through German music history, from Bach to contemporary rap - for enthusiasts, who feel like and still have room for something more.

The reading list for this course will be announced well before the beginning of the academic year via UGent's electronic learning platform.

Initial competences

The lectures and the discussions take place in German and hence required a lot of efforts from all participants, particularly in the beginning of the semester - participants need approximately 4 weeks to get used to the use of German as instruction language. In the first weeks of the semester, it suffices that you practice to understand what is being said. Gradually you will expand your proficiency in German, which you also acquire in other courses; having a good knowledge of Dutch (or another Germanic language) is definitely an advantage. Those who have no prior knowledge, will have to do an extra effort.

This course aims at a first acquaintance with German literature and with the instruments of literary studies.

Final competences

- 1 To be able to master and apply a basic knowledge of German (reading: short and medium size German texts with medium complexity; listening: understand a spoken exposition fluently; speaking: to take part in a simple dialogue; writing: to develop autonomously a statement in good German, with limited complexity and by making use of the acquired conceptual apparatus).
- 2 To be able to apply a basic knowledge of German literary traditions while analysing literary texts and
- 3 To have basic knowledge of German literary history and to be able to situate texts in it.
- 4 To be able to put the basics of analysis into practice when investigating German literary texts; to be able to use simple digital tools for text analysis.
- 5 To have a basic scientific insight in the specific characteristics of literary texts and the ways in which literature functions historically.
- 6 To be familiar at a basic level with scholarly methodology (sources, references, quotations, deontology).

Conditions for credit contract

Access to this course unit via a credit contract is unrestricted: the student takes into consideration the conditions mentioned in 'Starting Competences'

Teaching methods

Lecture, Practical, Independent work

Extra information on the teaching methods

- lecture: 30h (= weekly lectures of 150 minutes)
- seminar: 7.5h (= six exercises of 75 minutes, in which students make and discuss basic analytical exercises (speaking and writing) in German)
- self-study: 7.5h (students perform research activities on themselves, under the supervision of the lecturer, i.e. for personalized feedback, intermediary questions etc.)

Notice: this course entails a total workload of 150h; this encompasses the preparation of the

lectures (the reading), the attendance of the lectures and seminars, the preparation and the making of the exam, and the exercises; the workload for the exercises can be estimated on 15 to 20h).

Assessment moment

Post-sessional (80%) and in-sessional assessment (20%).

(If the student does not pass the non-sessional assessment, a second chance is offered by means of a compensatory activity between the first and second exam period.)

Assessment form

- Written exam: open book with 4 questions testing insight and comprehension, in a controlled setting; students cannot make use of digital tools.
- Oral exam: 2 knowledge questions (literary history; 20C history) and 1 comprehension question (on the basis of the student's reading).
- Continuous assessment

Reaching the desired level of language proficiency is part of the learning competences of this course. This proficiency is supported by feedback on writing tasks, by self-study and self-testing, and by participation in the tutorials.

Calculation of the examination mark

Post-sessional assessment:

Exam: 80%; the students become a mark with a maximum of 16 on the written exam (which consists of 2 analytical questions (each 1/3 of the mark) and two synthetic questions (each 1/6 of the mark); the oral exam adds to that a mark that varies from -1 (for the worst possible performance) to +1 (for the best possible performance).

In-sessional assessment:

Portfolio (with three assignments): 20% (4)
