Module Shannon Lambert: Medicine, science, bodies, fiction, biology, twentieth century, twenty-first century, nonhuman animals, laboratory literature. Module David Alvarez: British Literature and Culture; Restoration and 18th-Century British

Position of the course

This course is an elective, third-year course. It expands on the overviews given in the first two years of the bachelor. It focuses on (1) late nineteenth to contemporary American and British fiction and biomedical science, with a particular interest in the depiction of bodies both human and nonhuman animal; or (2) on Restoration drama, imperialism, and religion.

Contents

Students choose one of the modules below.

Module Shannon Lambert & Louise Benson James: American and British fiction and biomedical science

This interdisciplinary course will examine how scientific issues related to the body were

registered and interrogated across a range of literary genres (essays; novels; short stories; poems) from the 1880s to the present. Areas of interest that will shape our discussions include, for example: evolution and degeneration; theories of race, gender, sexuality and class; interactions of the mind and body; new understandings of illness and disease; animal experimentation; zoonosis and transgenesis; and medical ethics.

The contents of the course is guided by guestions such as:

- How is scientific knowledge addressed and transformed in literary writing?
- How do various literary forms influence the communication and reception of scientific theories and concepts?
- How transferable are reading practices and strategies across literary and scientific texts?
- Do fictional engagements transform how we understand knowledge and who, and what, counts in its production?
- Does literature have a role to play in ethical questions related to medical and scientific knowledge and, even, practice?

Module David Alvarez: Staging World Religions and Imagining the Secular in Restoration Drama

In the context of imperial conquest and early globalization, English drama in the seventeenth century often stages distant locales on the local London stage. Especially after the restoration of the English monarchy and established church in 1660, these spectacular productions imagine Mexico and Morocco, Ottomans and Mughals, in exotic fashion to think about crosscultural encounters and engage with global politics. Restoration theater plays an important but largely unacknowledged role in imagining world religions, and this course examines how and why the modern concept of religion is developed and deployed globally in Restoration drama. We will pay special attention to how different representations of religion are linked to the development of forms of toleration and secularism in these plays, as well as to imperial projects.

Nb. All learning and reading materials will be made available through Ufora.

Initial competences

English literature 1 or acquisition of skills for literary analysis by other means. Some knowledge of 19th century to contemporary literature, and literary theory will be helpful, but is not necessary for enrolment.

Final competences

- 1 To read texts in a wide variety of genres (novel, poetry, drama, short story, prose essay), paying close and critical attention to the production of meaning at the level of literary language and form.
- 2 An understanding of the relationship between literature and science and how it has evolved from the late nineteenth century to the present.
- 3 To write about texts analytically, using both close-reading skills and contextual scholarship to offer original critical commentary
- 4 An understanding of how the biological study of bodies developed in the medical sciences, and how writers of fiction engaged with these sciences.
- 5 Understanding the purpose and benefits of researching 'beyond the canon' and practical skills in researching using online archives.
