Teaching languages

French historical linguistics, phonetics, phonology, morphology, lexicon, inherited words, language evolution

Position of the course

The purpose of this module (1 block per week) is to give an insight into the genesis of French from Latin. More specifically, we will study : 1. the lexical heritage from Latin (the share of Latin inherited words in the French lexicon) 2. sound evolutions and their traces in contemporary spelling 3. similarities with other Romance languages.

This course prepares students for a thorough study of Old French texts.

Contents

The first part of the course focuses on the genesis of French from the perspective of general linguistics and external language history, with particular attention to the relationship between synchronic language variation and diachronic language

evolution, and on external influence on language change. An overview of the origins of the lexicon in French (hereditary words, loanwords, derivations, etc.) is followed by a study of the evolution of the phonetics of French and its impact on contemporary spelling. Particular attention is paid to the main phenomena underlying phonetic evolutions (e.g. the role of accent, palatalisation, nasalisation, diphthongisation, etc.). The analyses are illustrated with numerous examples and are accompanied by exercises in which the emphasis is not only on the analyses, but above all on scientific argumentation.

To have completed the French linguistics: introduction or to have mastered the intended competence in another way.

- 6 Have an understanding of the phonological system of contemporary French.
- 7 To know and understand the main mechanisms related to sound evolutions.
- 8 Explain the phonetic evolution of words and understand its impact on spelling.
- 9 To be able to interpret data, form hypotheses and build arguments.
- 10 To master the International Phonetic Alphabet (IPA) in its application to French.
- 11 Master the subject-specific terminology + be able to use the language grammatically correct and stylistically appropriate.

In addition, students are expected to study autonomously a part of the syllabus and to do some exercises in an independent way. During the classes references will be made to this material and there will be room to ask questions. Finally, the students also deepen one particular aspect of the course by means of a collective video presentation.

Participation during classes is also assessed.

Calculation of the examination mark

Written exam : 70 %; group work : 20 %; participation: 10%.

For the assessment of language proficiency, error scales are used.

To pass this course, one must participate in both the period-based evaluation and the non-period-based evaluation, and obtain at least 10/20 for both. If one has less than 10/20 for one of the two evaluation components, one can no longer pass the entire course. This means that if the final score would still be above 10/20, it will be reduced to the highest unsuccessful mark (i.e. 9/20).

Transfer of passed partial marks from the first examination period to the second examination period is possible.

Facilities for Working Students

1. Possible exemption from educational activities requiring student attendance
2. Possible rescheduling of the exam to a different time in the same academic year
3. Feedback can be given by email or during an appointment (on campus or online)
