Position of the course

- The objectives of the course "Turkish: Language Practice D" (T2PD) are:
- The students expand their vocabulary to about 4000 words;
- The students learn to analyse and translate texts of average difficulty in both directions;
- The students develop their active language skills, both orally and in writing;
- The students learn to judiciously use bilingual dictionaries;
- The students are aware of the specific use contexts of the lexicon, according to text type and register and they are aware of typical realia in the textual material.

Contents

In the course "Turkish: Language Practice D" (T2PD) the students increase their reading skills through analyzing and translating a number of Turkish literary texts. The themes include the oppositions between emigrants / non-emigrants, West / East, lower class / upper class. The texts illustrate different registers. The attention of the students is drawn to the typical Turkish realia mentioned in the text material. Besides the Turkish-Dutch translation of the text material, the students also do short Dutch-Turkish translations. They learn to critically use the existing dictionaries. A number of texts are read and analyzed independently by the students. The vocabulary of the students increases by about 1,000 new words. Specific themes are addressed in a systematic manner. Through a.o. discussion, role play and oral summary, listening and speaking skills are built up. To develop their writing skills, students are required to write essays.
