Position of the course

The unit of study "Spanish: Specialized Translation II" aims to familiarize students with specialized (legal and technical/scientific) translation. It teaches them a strategy for preparing their translations thoroughly (documentation, critical approach of sources, etc.) and for producing them. In addition, students are taught to apply the specialized terminology and the appropriate register in the target text correctly. In the translation process, the knowledge acquired on translation technology tools ("Terminology and Translation technology") is applied.

Contents

The unit of study "Spanish: Specialized Translation II" consists of:

- S4V2 Ju: legal texts
- S4V2_TW: technical/scientific texts

S4V2_Ju consists of:

- an introduction to various methods for finding technical terms in the legal domain (electronic and traditional tools; parallel texts, glossaries, terminology databases, etc.),
- an approach of the specific nature of the texts to be translated a) non-judicial texts (such as constitution or articles of a company) and b) judicial texts (such as a sentence or an arrest), focussing on the differences between the systems,
- an approach to the correspondent terminology, both in Spanish and in Dutch. The material is organized topically, each topic consisting of one or more exercises (human translation or revision of machine translation).

S4V2 TW consists of:

- a brief theoretical introduction to technical and scientific translation (a.o. genre conventions of technical and scientific texts),
- an introduction to various methods for finding technical terms in the technical and scientific (Approved)

domain (electronic and traditional tools; parallel texts, glossaries, terminology databases, etc.),

- the translation and revision of technical and scientific texts.

Initial competences

The student:

- is able, under supervision, to analyse and translate Spanish texts of more than average difficulty, as found in professional contexts; and can review/revise such translations
- can write Dutch texts of more than average difficulty, as found in professional contexts, both on the basis of instructions and on the basis of existing textual input;
- can make adequate and critical use of the relevant heuristic resources needed for the abovementioned tasks;
- has sufficient knowledge of translation technology tools and can apply them independently.

Final competences

- 1 Having a command of Dutch at professional native speaker level in terms of comprehension and writing skills, and of Spanish at a C2 level of the Common European Framework of Reference for Languages in terms of reading and comprehension [MV.1.1, assessed]
- 2 During the translation process, adequately applying advanced institutional knowledge and being able to reflect on the interinstitutional transfers [MV.1.2, assessed]
- 3 Having advanced knowledge of the scientific study of translation and, based on that knowledge, reflecting on translation as a process and as a product [MV.1.3, not assessed]

Seminar: the texts are made available through the electronic learning environment; they are introduced in the seminars and the translations are individually finished by the students; at given times, students furthermore review/revise other translations (from other students and MT output); the most relevant issues, solutions, and errors are discussed in class. First session:

S4V2_Ju (50%):

Written assessment: general legal aspects and vocabulary (without aids); translation and/or revision MT output of legal text passages similar to the studied texts (with the use of relevant resources).

S4V2_TW (50%):

Assignment: translation and revision of a technical and/or scientific text.

Second session:

S4V2_Ju (50%):

The same.

S4V2_TW (50%):

Only the students who passed the assignment in the first examination period, don't have to do the assignment and can keep the partial mark.

Calculation of the examination mark

The final score is the combination of the results obtained in both exams: written assessment (50%) + assignment (50%).

Students who do not take part in the assessment of one or more parts of the course evaluation, cannot pass the course evaluation; in that case the maximum score for Spanish: Specialized Translation II is 9/20.
