# Position of the course

The unit of study "English: Specialized Translation Practice" (E4GV) builds on previously acquired general translation competencies and introduces the student to more specialized translation. This study unit aims to professionalize all language and translation skills that have already been acquired in the Bachelor of applied language studies for English and Dutch.

From a horizontal perspective, this study unit ties in particularly well with Terminology and Translation Technology, Specialised Translation 2, the modules Audio-visual Translation, CAT and Website Localization, and Translation Revision.

## Contents

Two domains of specialized translation are illustrated in the unit of study "English: Specialized Translation Practice" (E4GV): the economic and the academic domains. Students become familiar with typical difficulties of specialized translation: search for adequate sources, acquire domain knowledge and translate specialized (audiovisual) texts following appropriate norms or style guides. In (international) teams, students also become familiar with the processes of revision and review according to the ISO 17100 norm and practise their skills in giving and receiving feedback. They sharpen their critical attitude vis-à-vis diverse forms of translation quality by means of commentaries of their own translations, those of peers, or of machine-translated texts with reference to recent translation studies.

#### Initial competences

The student:

- is able, under supervision, to analyse and translate English texts of more than average difficulty, as found in professional contexts; and can revise/review such translations
- can write English texts of more than average difficulty, as found in professional contexts, both on the basis of instructions and on the basis of existing textual input;
- can make adequate and critical use of the relevant heuristic resources needed for the above-mentioned tasks.

1 Judging and acting with the necessary dose of critical self-reflection about translations and translating texts in unpredictable, complex and specialist contexts.

# Extra information on the examination methods

#### Written examination

For the economic translation component, students are quizzed on their factual knowledge, and are also asked to translate one or two brief texts (these can be English to Dutch or vice versa) on a PC, consulting a large number of sources. For the academic translation component, students are required to translate a few short excerpts from English into Dutch on a PC, consulting a large number of sources. Students will also reflect explicitly on a few translation choices.

# Portfolio

Team and individual translations, revision(s), review(s), translation comments and individual vocabulary acquisition are tested.
