**Position of the course**

This unit of study aims at making students familiar with various basic interpreting techniques. Students learn how to interpret simple texts on a wide range of topics. They also learn how to manage interaction at a basic level. Students learn how to use communication resources which are mostly used in interpreting such as mobile guide gear, skype, telephone interpreting. Students are introduced to a number of popular and less specialized interpreting contexts such as business-, media- and public services settings.

**Contents**

In the first couple of weeks attention is paid to memory exercises, note-taking technique and paraphrasing exercises. Students become familiar with basic interpreting techniques such as short consecutive interpreting (with and without notes), long consecutive interpreting, chuchotage/whispered interpreting, sight translation and dialogue/liaison interpreting. Students learn to manage interaction (turn management, seeking clarification, etc.) The exercises are based on general topics. This allows students to draw up glossaries on specific topics. This unit of study prepares students for the Specialized Interpreting course.
