# Position of the course

This course unit aims at making students familiar with the basic techniques of interpreting. Students learn to interpret non-specialized speeches about a variety of subjects. They learn to deal with interaction management on a basic level. They learn to use modern communication tools such as infoport, telephone/smartphone and webcam. The students are made familiar with interpreting in non-highly specialized settings such as business, media, public service. They learn how to prepare for interpreting assignments.

#### Contents

During the first weeks students are made familiar with memorizing, note-taking and oral proficiency. Furthermore they learn different interpreting techniques such as consecutive without and with notes, whispered translation, sight translation and dialogue interpreting. The students learn in which context to use which technique.

Students learn to manage interaction (turn taking) and ask for clarification or repetition.

The exercises cover general subjects (e.g. media) and business settings. Students are made familiar with the usual preparation strategies and learn to draw up their glossaries. Students are also made familiar with different kinds of distance interpreting tools such as the telephone/smartphone, infoport, Skype and webcam.

# Extra information on the examination methods

First session:

Skills test (30%)

Students are assessed on the basis of at least one performance in consecutive interpreting and one exercise in dialogue interpreting. Knowledge of vocabulary is also assessed.

Oral examination (70%)

Students are assessed on the basis of different interpreting techniques: at least one performance in consecutive interpreting and dialogue interpreting. The examination panel for the oral examination consists of at least two members.

Second session:

Oral examination (100%).

Students are assessed on the basis of at least a performance in consecutive interpreting and dialogue interpreting, and if applicable also vocabulary. The examination panel consists of at least two members.
