**Position of the course**

The course aims at:

- the acquisition of a thorough understanding of and research experience in a specific genre, author, period, or problem from Ancient Greek literature; the less canonical literature from the imperial period is covered extensively;
- a deepening of the knowledge and skills acquired during the bachelor's degree, including actively participating in critical discussions about primary and secondary literature, applying different literary theories and methods to Ancient Greek texts, and understanding, interpreting, and presenting Ancient Greek texts using professional tools.

**Contents**

The course targets research-oriented discussion and analysis of selected texts from Ancient Greek literature. Detailed analysis is preceded by one or more theoretical introductory lectures. At least one lecture is taught by a guest speaker with research experience in the theme of the course.

Theme 2025-2026: Greek biography and fiction

We cover the history of the biographical genre and problematize the concept of 'fictionality' in this genre. Both ancient and contemporary theoretical approaches to the concepts of fiction and fictionality are addressed. The focus is on reading and analyzing various examples from Ancient Greek literature, from the classical period to the early Middle Ages.

**Initial competences**

A good knowledge of the Greek language and a clear understanding of the main genres in Greek literature, as acquired during the bachelor training programme.

## Final competences

- 1 Applying literary theories and methods to the analysis of Ancient Greek texts.
- 2 Acquiring a broad knowledge of and familiarity with classical literature from various (also non-canonical) genres and periods.
- 3 Collaborating with fellow students.
- 4 Understanding, interpreting and presenting Ancient Greek texts to an academic audience, making use of appropriate professional tools.
- 5 Presenting personal research findings orally.
- 6 Participating actively in critical discussions of primary and secondary literature.

#### **Extra information on the examination methods**

The student attends and actively contributes to the lectures and seminars (preparatory reading, taking notes, participation in class discussions, micro-teaching).

The student delivers a 20-minute oral research presentation on a topic of choice from a list of selected topics.

During the oral assessment, the student's understanding and individual processing of the material covered in the lectures and seminars will be assessed (no reproduction of knowledge).

For the research presentation, generative AI may be used to (1) compile a bibliography, (2) help structure arguments, and (3) edit the presentation. Appropriate use of AI will be further trained and defined during one of the seminars.

#### **Calculation of the examination mark**

- 1) continuous assessment - participation in lectures and seminars: 20%
- 2) continuous assessment - research presentation: 50%
- 3) end-of-term assessment - oral assessment: 30%

#### **Facilities for Working Students**
