**Position of the course**

This module is one of the two core modules of the research focus Ancient History on BA3 level. Building on knowledge about the ancient world acquired in the first two bachelor years, it offers a survey of the later Roman Empire (AD 284-641) and focuses on sources, methods and debates, with the aim of allowing students to navigate this field of study independently. It is also of interest to students interested in the early middle ages, early Islam, and the history of Christianity.

**Contents**

The later Roman Empire is marked by profound political, religious and cultural transformations. Political reforms changed the power balance within the empire, as well as between the Romans and their neighbours. The rise of Christianity not only reshaped the religious landscape, but also had a profound impact on fields as diverse as the care for the poor and the writing of literature. And the fusion of classical and new artistic and linguistic traditions changed the world of culture. As the resulting political, religious and cultural changes had a profound impact on the empire and its inhabitants, they generated numerous conflicts.

This module focuses on these conflicts in order to offer a survey of the main lines of development, the main sources, and current approaches and debates of the history of Late Antiquity. The course discusses themes such as autocracy and bureaucracy, crises and riots; paganism vs Christianity, church councils and conflicts; barbarian migrations, integration and state formation; climate change and plagues; the history and myth of the fall of the Roman Empire.

**Initial competences**

Basic knowledge of the ancient and medieval world, acquired in the survey courses of BA1 or in any other way.

**Final competences**

- 1 To have a firm knowledge of the history of the later Roman Empire
- 2 To be able to explain the main concepts, changes, and debates in scholarship in the field of Late Antiquity, and critically reflect on them
- 3 To be familiar with the main sources and source types used for the study of the later Roman Empire
- 4 To be able independently to discuss and critically evaluate late antique sources.
