Position of the course

The study unit "Spanish: Grammar B" (S1SB) teaches students not only to recognize and analyze the basic structures of Spanish, but also to express themselves in a grammatically correct manner, with a view to other study units and to the subsequent years.

Contents

This study unit covers the following basic structures:

- the simple and compound sentences
- the use of modes and tenses
- passive voice constructions and their use

- the use of 'ser' and 'estar'

The course is thematically organized. The approach is mainly normative, and contrastive where appropriate. The exercises are both receptive (analysis) and productive (gap-filling exercises and some translation exercises).

Initial competences

- the student is familiar with the terminology of the word types and the modes and tenses of the verb in Spanish;
- the student is able to apply the basic rules of the Spanish grammar with regard to the word types and to conjugate the verbs in all modes and tenses.

Final competences

- 1 Having a command of Spanish structures at B1 level of the Common European Framework of Reference for Languages, in terms of writing skills, provided that the competences of S1SA and S1PA have been previously acquired. (B.1.2 assessed)
- 2 Having a command of the basic structures of the Spanish language with regard to the syntax of the simple and the compound sentences, the use of modes and tenses, the formation and use of the passive voice and the use of 'ser' and 'estar'.(B.1.2 assessed]
- 3 Having a command of the basic terminology of the Spanish grammar regarding the syntax of the simple and the compound sentences, the use of modes and tenses, the construction and use of the passive voice and the use of 'ser' and 'estar'.[B.1.3 assessed]
- 4 Recognizing and independently interpreting grammar structures of the Spanish language, with close attention to the analysis of the simple and the compound sentence and with attention to contrastive aspects (Spanish versus Dutch). [B. 1.3 assessed]
- 5 Having knowledge of reference works and electronic aids, using them adequately and efficiently retrieving specific information about Spanish grammar. [B2.2, not assessed]
- 6 Having a strong language awareness. [B.3.1, not assessed]
- 7 Thinking and reasoning analytically and creatively in order to solve unfamiliar, complex problems, that is, to analyze known structures in a new configuration. [B.3.2 assessed]
- 8 Displaying intellectual curiosity and a lifelong learning attitude. [B.3.4 not assessed]
