**Position of the course**

The study unit "Turkish: Cultural History" (T2CG) gives a survey of the history of Turkey in order to acquire important social, structural and cultural background knowledge on the country. The study unit takes into account the linguistic knowledge acquired in the first two years of the Bachelor.

Exchange students may take up this course unit, for which no prior knowledge of Dutch is required.

**Contents**

The study unit "Turkish: Cultural History" (T2CG) gives a comprehensive political, socio-economic, administrative, geographical and artistic overview of Turkish history and Modern Turkey and is based on themes: (e.g. Anatolia before the arrival of the Turks, the earliest history of the Turks in Central Asia, the Seljuq and Ottoman Turks, the Republic of Turkey, geographical characteristics of Turkey, the population, holidays, religion, tourism in Turkey, social traditions, traditional sports, Turkish cuisine, music and art).
