Position of the course

The unit of study "Turkish: Literature" (T3LI) aims to acquaint the students with Turkish literature, set against the backdrop of Turkish cultural history. Students are acquainted with literary references and their connotations. They are taught to use heuristic resources in order to gather and process literary information. Exchange students may take up this course unit, for which no prior knowledge of Dutch is required.

Contents

The unit " Turkish: Literature" (T3LI) gives an overview of the most important authors and literary movements in Turkey since the 19th century. The students receive a reading assignment.

Initial competences
