Position of the course

The aim of this unit of study is to provide students with a concise overview of the theory and deontology of conference interpreting.

Contents

This unit of study provides an overview of the following aspects of conference interpreting:

- theoretical concepts and models of conference interpreting
- main currents in interpreting studies
- deontology and codes of conduct in the field of conference interpreting

Initial competences

Skills to be expected of a Master graduate with a broad interest in conference interpreting or of a four year's bachelor in interpreting.

Final competences

- 1 Students can situate simultaneous and consecutive interpreting as a specific kind of communication, different from translation, requiring specific skills.
- 2 Students are able to assess the quality of interpreting on the basis of scientific and empirical criteria.
- 3 Students are able to describe on a theoretical basis the qualities required of a professional conference interpreter.
- 4 Students are aware of the deontologic rules applying to conference interpreters.
- 5 Students are able to search for information in relevant scientific sources.
