**Position of the course**

The study unit "Turkish: Language and Career" (T4TB) builds on the knowledge and skills acquired in "Turkish : Language Skills" and familiarizes students with the specific language and terminology used in companies, organizations and in the judicial and social sectors. Students are trained in the adequate use of specific oral and written communication techniques and learn to translate and consecutively interpret specialized texts from Turkish into Dutch and from Dutch into Turkish.

**Contents**

The study unit "Turkish: Language and Career" (T4TB) concentrates on the fields of asylum, welfare and education. It integrates both oral and written communication techniques. Students translate specialized texts from these fields in both directions (from Turkish into Dutch and from Dutch into Turkish), produce texts from various professional contexts and are introduced to various interpreting techniques.

**Initial competences**

The student:

- is able to produce Turkish texts of more than average difficulty, as found in various professional contexts;
- is able to understand, analyze and both translate and revise under supervision Turkish texts of more than average difficulty;
- is able to communicate orally in Turkish in a number of professional contexts;
- can make adequate and critical use of the relevant heuristic resources needed for the above-mentioned tasks.

**Final competences**

- 1 Having a command of Turkish at C1 level of the Common European Framework of Reference for Languages for comprehension (listening and reading), oral skills (production and interaction) and writing skills. [MC.1.1., MT.1.1; MV.1.1.; assessed]

- 2 In the context of communication strategies of organisations, providing effective written and oral communication in Turkish. [MC.6.1; assessed]
