Position of the course

This unit of study aims to acquaint students with some basic interpreting skills and techniques. Students learn to interpret simple texts on a wide range of subjects between German and Dutch in diverse contexts, including business, media, and public service. They also learn how to manage interaction on a basic level. They practice both on-site and distance interpreting.

Contents

During the first few weeks, students are trained in memorizing, note taking and oral proficiency. Students are introduced to the different interpreting techniques: consecutive with and without notes, chuchotage, sight translation and liaison interpreting. Moreover, they learn to manage interaction (turn taking, asking for clarification or repetition). The exercises cover general subjects, which allows students to draw up their own glossaries. This unit supports the Specialised Interpreting Unit.

Initial competences

- are able to understand written and spoken German texts of a more than average degree of difficulty from a range of professional contexts and reproduce them orally in another language.

Calculation of the examination mark
