Position of the course

The purposes of this unit of study are:

- familiarize students with several interpreting techniques;
- train students to successfully interpret simple texts on ;different topics;
- train students to manage interaction;
- train students to use communication tools while interpreting;
- familiarize students with interpreting contexts such industry, media, public services.

Contents

First weeks: memory training, note-taking and oral formulation skills; After: familiarize students with the basic interpreting techniques: consecutive (long and short), whispering, sight translation, dialogue interpreting. COVID19: part of the classes will be delivered online in 2020-2021.

Initial competences

Students are able to:

- understand spoken and written French texts of considerable difficulty as appropriate in professional contexts and reproduce these orally in a different language;
- put the appropriate heuristic aids to adequate and critical use in doing so.

Final competences

- 1 master French at the EFR C2 level for comprehension and speaking
- 2 show concentration, stress resistance and good memory and master note-taking
- 3 possess advanced knowledge of the interpreting industry, relevan institutional and cultural backgrounds, aspects of intercultural communication and apply these to the interpreting process.
- 4 be able to manage the interaction between the primary speakers during the interpreting process.
- 5 be able to justify interpreting options, based on scientific sources and communicate this knowledge to clients and colleagues.
- 6 take into account linguistic and cultural sensitivities and respect for diversity in the professional context and the broader social debate.
- 7 be able to apply relevant strategies and relevant tools to improve his/her own efficiency.
- 8 show a willingness for life long learning, including new developments of the discipline, be able to reflect on these.
