**Position of the course**

This course provides insight into the law of the sea, broadly governing the rights and duties of states in marine areas. This legal regime regulates various activities at sea through a spatial division in distinct maritime zones (entailing different rules for navigation, exploitation and protection of natural resources) and a number of overarching principles. During this course, students also learn to critically assess new developments in the law of the sea within its broader political and economic context, including sustainable development goal (SDG) 14.
