Position of the course

To give insights into the relations between animal and law, in the perspective of the historical backgrounds and the social factors.

Contents

In this course the relations between animal and law are dealt with, in the perspective of the historical backgrounds and the social factors. The emphasis is laid on Belgian and European law, sometimes in a comparative approach (Netherlands, Germany), and attention is paid to policy aspects and legal technical aspects.

The topics include:

- animals and law in general: philosophical aspects; animal rights; animals and ownership; species versus individual approach; animal welfare versus animal health; pest animals?; responsibility for animals;
- animal welfare law: historical aspects; study of the existing Belgian and European animal welfare law;
- animal health law: sanitary legislation (mat cow disease, etc.); legislation on hormonal products; food safety legislation; etc.

Initial competences

- to have a knowledge of the basics, the structures and the methodology and systematic of Belgian law
- to have the abilities to analyse and to valuate legal texts and sources, to solve legal problems
- to have the attitude to be willing to develop a critic and scientific attitude
