Non-periodic: evaluation of written and oral skills, evaluation of knowledge: 2 written tests (vocabulary, grammar) and an oral presentation based on a written account of findings from recent scientific research.

Periodic: written exam and listening test.

Calculation of the examination mark

First exam period:

Non-periodic (50%)

Period-specific (50%)

Second exam period:

Non-periodic (30%)

Period-specific (70%)

Note that (i) every student is required to participate in every assessment moment.

If not, the student will fail. Specifically, if the final score would still be a mark of ten or more out of twenty, that final score will be reduced to the highest non-passing grade.

Note also that (ii) there is only a partial second chance for non-periodic evaluation. The results of the paper and oral presentation (together 30%) are transferred to the second examen period, the results of the 2 knowledge tests (grammar and vocabulary, together 20%) are not. As a result, the period-specific evaluation in the second exam period counts for 70% of the final result (as opposed to 50% in the first exam period).

Facilities for Working Students

Class attendance is recommended to successfully complete the course (at least 2/3 of the lessons). Class attendance is mandatory for a number of teaching activities. No online/digital facilities (lectures take place on campus, without recordings). It is not possible to take the exam at another time.
