#### Position of the course

In a study which focuses on care, health and corporeality, it is of crucial importance

- to situate the technical therapeutic skills in a broader view of life and its societal and philosophical context,
- to become an insight on these diverse contexts,
- and also to develop the skill of reflecting at these insights in a methodical and systematical way.

#### Contents

In the first place we explore the field of philosophy and of reflection in general, and the basic requirements needed for that: methodological doubt, systematical and logical reflection and structured thinking. Next we dive deeper into the historical intertwining of medical and philosophical thinking. We analyze how these two worlds are interwoven with each other and constantly influenced one another. Several themes are discussed and situated, each of them having a specific relevance for this study: disease, health, corporeality, identity, diversity, technology, etc. We end up with the question how contemporary society influences the way we experience our corporeality and identity, individually as well as in relation to others.
