### Position of the course

This course provides a basic overview of the development, characteristics, functioning and activities of the EU. It is especially designed for students without a prior knowledge on EU law.

### Contents

After an overview of the principal sources of EU law, the main EU institutions (European Council, Council, Commission, European Parliament, Court of Justice) and the EU decision-making process are discussed. An overview of substantive EU law (internal market and competition law) is provided. In this course, judicial protection is examined by means of an analysis of the leading judgments of the Court of Justice and the General Court

- 6 identifying, searching and using the sources of EU law.
- 7 critically discussing the basic judgments of the Court of Justice.
- 8 critically discussing and evaluating recent developments in EU law.
