Position of the course

The aim of this course is to enable students to critically analyse and evaluate scientific research and to set up and do scientific research of good quality. In previous courses, students focused on the different research methods (qualitative and quantitative) and the different research phases (problem definition and research design, data collection and analysis, and reporting results). The aim of this course is to give students the opportunity to further develop their research competences, on the one hand for conducting scientific research for their master's dissertation, and on the other hand for developing a general critical attitude towards scientific research.

Contents

The course is organised in clusters linked to the different research phases (see above). In each phase, the course provides theoretical frameworks which students will actively apply themselves. The aim is to activate the competences obtained in previous methodology courses, supplementing and strengthening these where necessary. More specifically, we deal with the following aspects:

- 1 Research design: writing problem statement, choosing right design and developing a research plan
- 2 Doing research: selecting and using data collection methods and analytical methods (incl. data management) in function of the research questions
- 3 Reporting and presenting research

Initial competences

Basic knowledge of research methods and techniques in the social sciences and certain competences acquired in earlier bachelor programmes that allow access to this master. This course builds further on certain competences acquired in the research method courses in the bachelor and the linking courses.

Final competences

- 1 Reporting critical reflections on qualitative and quantitative research (conducted by the student, or existing research), in particular regarding the problem

definition, research design, data collection and analysis and reporting, and the coherence between these elements

- 2 Formulating a relevant problem definition for conducting own research in the public administration and/or public management domain
- 3 Setting up own qualitative and/or quantitative empirical research in a self-developed research design focusing on a public administration and/or public management theme
- 4 Planning data collection and analysis for an own research project in a way that is coherent with the research design
- 5 Reporting research results in a scientific, ethically responsible and legible way
- 6 Suggesting points for improvement for the different phases of the research of fellow students (problem definition, research design, data collection and analysis and reporting)

During the lectures, which follow the different research phases, important research components, methods and techniques are refreshed in an interactive way.

During working sessions, students make a critical reflection of their own (planned) master's thesis by applying frameworks from the lectures. They give feedback to fellow students and receive feedback on their own work.

In preparation of the working sessions, students autonomously use methodological sources and prepare critical reflection notes of their own and fellow students' work.
