The overall objective of the course 'Organizational Behavior' is to enhance the understanding of organizations on three levels: organization, group and individual.

The course is divided into three major parts. # Calculation of the examination mark

Exam: 60% Paper: 40%

When the students obtains less than 10/20 for at least one of the components, they can no longer obtain a pass mark for the course unit as a whole. If the total score does turn out to be a mark of 10 or more out of 20, this is reduced to the highest fail mark, 9/20.

If students pass the group assignment but not the exam, the points of the paper may be transferred to the second examination period. If students pass the exam but not the group assignment, the points of the exam can be transferred to the second examination period.

Students who eschew one or more parts of the assessment can no longer obtain a pass mark for the course unit. Should the final mark be higher than 7/20, it will be reduced to the highest non-tolerable mark (i.e. 7/20).

Not adhering to deadlines for the group assignment without valid and substantiated reasons (such as illness) will result in a zero for the group assignment.
