History of contemporary society, history of Belgium, history of the state.

Position of the course

This basic course teaches students that contemporary society is the historical outcome of economic, social, cultural and political developments. How institutions (in its broadest sense) originate, function and evolve is the result of policy choices and political decision making processes rooted in specific historical settings. Through a historical frame of reference the action of the state as a public actor who serves the public interest in Belgium will be explained. The students will be able to understand and critically judge the present constellation in Belgium on the basis of a historical insight.

Contents

Central is the history of the state. The concept state will be scrutinized and related to concepts which further qualify the state such as liberal state, democratic state, nation-state and the rule of law. The history of the state will be analyzed by looking into the shifting grounds of the public and the private, or in more restricted sense the state and the market. Also how the state gives meaning to citizenship will be scrutinized. In this history we will look into how the state defines the nation and what the position was of the state on the cleavage between labor and capital. Throughout the course the history of the state in Belgium will be tackled chronological. The development of the actions of the state and the manner by which the state operates will be inbedded in the broad social, cultural and economic evolution of Belgium. A chronological overview of the history of Belgium will be presented. The focus is on the interactions between the different themes and (dis)continuity, with specific attention for the actors (decision makers) in political processes and structure.

- 4 The students analyze critically contemporary developments from a historical perspective.
- 5 The students position information within the appropriate historical context.
