Position of the course

We live in an age of collaboration: both private as well as public organizations increasingly collaborate in networks to achieve their goals. This evolution however raiszes new management and governance questions and challenges. Bachelors in Public Administration and Management should not only know about these questions and challenges, but should also be able to analyze them and to suggest how to improve the management of networks.

Contents

The course starts with an introductory part on what collaborations and networks are an are not about. Next, the course focuses on the main dimensions of network management, namely:

- 1. Ambition: working on a shared ambition
- 2. Interests: Serving interests
- 3. Group dynamics: collaboration is a human activity
- 4. Organization: organizing collaboration professionally
- 5. Process: Shaping a meaning giving process

To conclude, we connect the different dimensions again to evaluate network management and how it can be adapted if necessary
