Governmental organization of alien policy, and in particular immigration policy. Challenges for admission and integration policy. Target groups of immigrant and migrant policy, SDG 10. Reduce inequality within and among countries

**Position of the course**

This course is part of the learning track sustainability in the programme Public Administration and Management. In this course will be discussed:  
 How to facilitate orderly, safe, regular and responsible migration.  
 Linking (earlier acquired) general knowledge about public management, administration and public policy with this specific policy domain that is central to the sovereignty of the nation. A policy field that decides who will be granted access to the territory, but also for what time period and under which conditions this admission to the territory, but also to the economy, the welfare community and the nations will be granted.  
 Familiarize the students with the concepts proper to immigrant and migrant policy  
 Introduction to the actors involved in the field of immigration and migration policy, including their institutional embedment.  
 Providing insight into recent developments within and challenges for the admission and integration policy.

**Contents**

Within the immigration and migrant policy the following topics will be presented:  
 -The different admission channels into Belgium/Schengen/EU (labor and other economic migration, asylum, student migration, follow on migration (family formation and reunification) and irregular migration. Attention will also be paid to return and border policy.  
 -For those who are granted admission to Belgian territory their access to the Belgian nation (naturalization) as well as the (Flemish) integration policy will be presented.  
 -The different administrative categories (in particular third country nationals and EU-citizens)  
 - Actors involved in the policy and institutional framework

Practice:

-Conducting a small scale research project to map a contemporary development in this domain.

**Initial competences**

Knowledge (public) management, public administration, policy studies.

**Final competences**

- 1 Knowing the essentials and the complexity of immigration- and migrant policy.
- 2 Knowing the essentials of the institutional organization of this domain in Flanders/Belgium and its international/European ramifications.
- 3 Being able to reflect critically about topics in this policy field.
- 4 Being able to conduct a problem-driven research project in the domain of immigration and migrant policy.
- 5 Being able to communicate about this research in a written paper.
