## Position of the course

This course provides an overview of the EU's structure and decision-making procedures, focusing on developing key analytical skills in students to assess political arguments and interests on different sides of debates in the EU today. The course deepens knowledge on the functioning of the EU, and the underlining principles and values of European integration. Students are expected to engage with materials in a critical manner, and the lecturer will highlight multiple political perspectives for the development of the EU today, and for specific debates within policy areas and on the future of the EU more generally.

- Policy case studies: selection of in-depth studies of policy on trade, climate change, environment, energy, agriculture or migration
