This course is situated within the Bachelor program (2nd year) Psychology.

### Contents

This course addresses the following topics:

- contemporary theories/models of personality
- assessment of personality
- biological and behavioral-genetic perspective on personality
- Stability and change of temperament and personality across the life span (infancy, childhood, adolescence, early-mid-late adulthood)
- personality disorders: content, assessment, and development across the life course
- personality from a forensic perspective
- personality and functional domains of living:
  - school experience, career choice, dark professional functioning, life-long learning
  - romantic relations, family life, and parenting
  - peer-relationships
  - quality of life, health and longevity
  - life-events and coping

### Initial competences

This course builds on certain course competences of Differential Psychology.

## Final competences

- 1 To explain and apply different perspectives on personality and (abnormal) personality development
- 2 To be aware of strengths and weaknesses of different methods of personality assessment
- 3 To discuss personality pathology from a categorical versus a dimensional framework
- 4 To evaluate the relevance of scientific studies. To interpret research results in view of the research hypothesis
- 5 To indicate how (maladaptive) personality traits are significant in daily life across different contexts. To understand the relative significance of personality in human functioning against the background of other psychological factors
- 6 To explain the relevance of personality information for understanding maladaptive behavior. To use and apply personality information in the course of profiling of socially-deviant behavior
