**Position of the course**

A regional specialization viewing African societies, and eventually the globe, from the perspective 'Power and medicine'.

**Contents**

- (1) History of medical anthropology; culture-bound syndromes and traditional healing; body, illness and medicine. 3 sessions
- (2) Theoretical developments: transcultural psychiatry, critical medical and sensorial anthropology. 2 sessions.
- (3) Methodology: ethnographic fieldwork of non-Western concepts of health and illness. Case studies in Epistemologies of healing (Lake Victoria). 2 sessions.
- (4) Topics (3 sessions): a. Translating health issues among diaspora and asylum seekers, b. HIV prevention and stigma in Africa c. Poverty, war and trauma.
- (5) Student Projects (1 session)
