**Position of the course**

This specialised course is an optional component of two master programmes: the Master in EU studies (main subject Specific EU issues), and the Master in Oriental Languages and Cultures.

The course aims at providing the students a broad and in-depth understanding of the relations between the EU on the one hand, and East Asia, Northeast Asia, and Central Asia on the other hand. It benefits from the extensive expertise at the Centre for EU Studies and the Department of Languages and Cultures at Ghent University. It will also be linked to regular academic events organized by both research groups. Through interaction with the lecturers, students learn to participate in a debate on an academically high level in English.

**Contents**

This specialized course gives an overview and analysis of 1. East and Northeast Asia (historical, political and economic context of China, Japan, North Korea and South Korea, the Central Asian republics), 2. The EU's external policy (historical evolution and institutional context), and 3. Regionalism in Europe and in East, Northeast and Central Asia. This framework serves as a basis for the elaboration

on the relations between the EU and the rapidly changing East, Northeast, and Central Asian region. Courses on the current EU-East Asia relations will address topics such as geopolitics, geostrategy, geo-economics, cultural traditions and values. Closer attention will be paid to a number of specific issues in the EU's bilateral relations with Asian countries. For example, this could be the 'Belt and Road Initiative', the EU's 'Global Gateway' policy, or the position of the EU in the cross-strait issue.

### **Initial competences**

- All students of the Master in EU studies (Main Subject Specific EU Studies) and of the Master in Oriental Languages and Cultures are allowed to take this specialist course.
- No specific prior knowledge is required. The course builds further on a general level of academic thinking and working; generally acquired knowledge on the EU's external policy and a background knowledge on East Asia, Northeast Asia, and Central Asia is recommended.

### **Final competences**

- 1 1. To gain insight into the complexity of political, economical and security dynamics in the East, Northeast, and Central Asian region.
- 2 2. To gain insight into the complexity of the EU's foreign policy towards these regions
- 3 3. To have the knowledge to critically interpret the current role of the EU in East and Northeast Asia - namely China, Japan, ROK and DPRK - and the Central Asian republics, against the background of a changing global order.
- 4 4. To be able to elaborate a well-argued opinion with respect to the area and contextualize specific bilateral issues within these relations
- 5 5. To gain a profound knowledge of the various areas of EU's external actions in East and Northeast Asia
- 6 6. To be able to independently and critically follow up current political events in the area
- 7 7. To be able to present a critical analysis of recent developments in written form (English) in an academic paper
