Position of the course

The course allows to theorize on previously acquired knowledge on international politics. It is also crucial for the development of the Bachelor and Master dissertation. The course has two objectives: 1) familiarizing students with the main theoretical perspectives for the study of international politics, 2) teaching the application of these theories.

Contents

After an introduction to actors, levels of analysis, and the concept of power, thorough examination is conducted on realism, liberalism, English School, Marxism, neo-Gramscianism, social constructivism, feminism, post-colonialism, and analysis of national foreign policy.

Initial competences

- A general historical framework and a basic factual knowledge of contemporary international politics are required. Reading a comprehensive book on international politics from 1815 to the present is recommended.
- Students are expected to closely follow international topical developments throughout the academic year so that they can adequately apply theoretical insights to them.
- Students must be open to theoretical approaches that go beyond the anecdotal and journalistic.

- 6 Being able to independently and creatively apply the important theoretical paradigms in international relations to the development of the Bachelor and Master dissertation.
- 7 Being able to critically evaluate studies on international politics from theoretical and methodological perspectives.
- 8 When observing international trends and events, being able to transcend a journalistic or anecdotal approach by systematically demonstrating a theoretical, scientific reflex.
