Position of the course

This course offers students knowledge about some key issues, themes and concepts within the debates in global history and post-colonialism.

Contents

This course offers an overview of the history of globalization, the territorial and societal (intensive) expansion of capitalism in the Global South and of the different conflicts that are related and gave form to the political, economic and social processes of globalization. This course also offers the theoretical frameworks to analyze and understand these processes critically. Important subjects that will be treated are:

- The pre-colonial and pre-capitalist civilizations
- The emergence and constitution of the capitalist world-system
- Mercantilism, Free-trade, Free-trade imperialism and late-imperialism
- Slavery and Capitalism
- Colonization, decolonization and violence
- Revolution and liberation
- The history of racism
- Struggles for independence and the developmental state in the Global South
- The History of ideas and the role of Black Atlantic humanism

The course will be divided in to Lectures (HOC) and seminar sessions (reading groups in which the required literature is discussed in group and a report of the discussion is required).

Final competences

This course is a historical and critical analysis of the making of contemporary globalization, starting from the expansion of European domination, the colonial system and the development of the capitalist world system and its impact in the Global South. Specific attention will be paid to the different structures and conflicts that constituted our contemporary form of globalization. These structures and conflicts will be elaborated through particular case-studies. The course offers a theoretical framework to understand and situate contemporary developments and conflicts in the Global South and gives more insight into the interconnectedness of our world.

Extra information on the teaching methods

ex-cathedra lectures: the meetings in the auditorium will exist out of lectures in which the course is explained with powerpoints and video-material. Discussing relevant texts together in class (seminar form). Independent work: students are required to read the texts from the reader independently and before coming to class. groupwork and independent work:

-the students will be subdivided into seperate readingroups (max. 10 students). These readinggroups have to come together at least one time to discuss one of the texts from the reader (to be determined by the lecturer). A written report of the discussion has to be submitted as a group work (max. 5 pages).

-Students write discussion notes about the required readings and submit them before coming to class

Extra information on the examination methods

Permanent evaluation in first session:

Students write a written report of the discussion in the reading groups (3-5 pages) and – if possible – relate it to themes that were discussed in the lectures. This is a group work. One report per reading group is required.

Students write a discussion note of the required texts before attending class (these discussion notes are up for evaluation)

Students participate in class during discussions and are evaluated at particular moments during class seminars and/or simulation excercise (to be decided at the beginning of each academic year, depending also on the amount of enrollments) Evaluation forms which require participation can be adapted depending on the situation with regard to Covid 19

Written exam and final paper in second session

For those students who fail the permanent evaluation, a different evaluation method will be organized during the second session: 1) a written exam based on essay questions and 2) a written essay (subject to be decided in consulation with the lecturer)

Depending on the Covid 19 situation, the written exam can swith to an online form of oral examination.

Calculation of the examination mark

- permanent evaluation (first session), weight of each excercise to be announced in introductory class
- Written examination and final paper (only in second session): weight 50% for each excercise
