**Position of the course**

We are living in a multipolar world. There are several great powers, i.e. states (or unions of states) whose decisions have global impact, but none of them has sufficient power to dominate world politics by itself. Those great powers cooperate, but they are competing with each other at the same time: for influence, resources, partners and prestige. This interaction determines world politics. This is about war or peace.

In this context, understanding the Grand Strategies of the great powers is crucial: what are their objectives, which instruments are they deploying to pursue them, what is their resource base, who are their partners? Strategic thinking in general is essential in order to produce quality decision-making.

**Contents**

This course starts looks at the concept of Grand Strategy by way of 10 characteristics and, at the same time, analyses the Grand Strategies of the US, China, Russia, and the EU. Each of the 10 characteristics is illustrated, moreover, with historical examples, and the strategic history

of the current great powers is outlined.

Academic guest speakers and senior diplomats and/or military officers will bring their specific expertise to the course. An annual excursion to the Royal Military Academy in Brussels, where lectures on military strategy will be offered, is an integral part of the course. Additional excursions can be arranged.

Aim of the course: to understand current world politics through the Grand Strategies of the great powers, in their historical context.

### Initial competences

Solid historical background knowledge is advisable. To have successfully completed the educational components 'The History of World Politics (1815-today)' and 'Theories of International Relations' is recommended.

### Final competences

1 To acquire academic knowledge of, and insight into, the evolution of international relations in the 21st century.

2 To be able to explain the interaction between economic, political, military and ideological trends in contemporary international politics.

3 To be able to define the relation between internal and external strategy of states.

4 To be able to recognize (semi-)constant mechanisms in the articulation of (international) society.

5 To be able to articulate one's own position, orally and in writing, in a policy-oriented setting.
