Position of the course

This is a general course in the Major European and World Politics (Ba Political Science). The course aims to provide the basic concepts for studying regional integration in Europe and for making critical and scientific assessments of European politics. At the same time, attention goes to processes of regionalism outside Europe and to comparative regionalism. The course prepares students who aim to write a Master Paper in EU Studies or who are preparing a Bachelor Thesis on the EU or other forms of regionalism. The course also provides traditional and critical frames to reflect on these phenomena. Much attention goes to ongoing and topical developments and to debating EU politics.

Contents

This course includes a traditional overview of European integration theories (federalism, neo/functionalism, (liberal)intergovernmentalism, multi-level governance, europeanization, criticial theories, new institutionalism, constructivism). Each time the relevance eof theories for other regions is considered and there is also attention for comparativee regionalism. Theories are contextualized by reference to their scientific and societal context. There is special attention for critical assessments of traditional theories and for critical approaches to European politics,

including decolonization debates. In addition, much emphasis is on current developments in EU politics, how these can be analyzed scientifically.

There are also exercises and an exford style debate on a specific topic, for which students are divided in small groups.

Initial competences

- 5 Being able to theoretically assess current evolutions and events in EU and other regional politics.
- 6 Being able to write a theoretically informed research paper on EU/regionalism.
- 7 Witnessing a critical attitude towards statements on dynamics of regional integration in the EU and elsewhere, with attention for power and ideological dimensions.
- 8 Being able to find relevant academic texts on the EU or regionalism, to synthesize and critically assess them.
- 9 Being able to apply theories on European and/or regional integration to a specific case.
