**Teaching languages**

**Position of the course**

The goal of this course is to impart to the students in Master of Arts in the Communication Sciences a better than average command of the Dutch language, in accordance with expectations in the field of action where the students will end up working.

Admission is free for students from the defined programmes. Apart from these students a maximum of 6 students can be admitted. This restriction is not related to the type of contract.

**Contents**

Structured overview of the most common issues in the mastery of a language: how to do you write something (spelling/punctuation)? What is the correct pronunciation? What is the correct word? How do you improve syntax and style? Students independently assimilate the 'material', using a textbook and suitable websites. During the seminar additional explanation is provided where needed, while the main emphasis especially lies on doing plenty of exercises.

**Initial competences**

Solid basic knowledge of Dutch

**Final competences**

- 1 The student can handle the sources that inform him/her on what is correct/wrong, appropriate/less suitable in Dutch.
- 2 The student is able to recognize and correct errors in Dutch in texts and improve texts stylistically.
- 3 The student is conscious of the fact that what is considered to be correct or wrong changes in time.
- 4 The student is aware of the fact that he/she will have to continue to gather information on evolutions in the use of a language and the attitudes toward this.
- 5 The student is able to choose in front of different target audiences the words and expressions from the correct register.

## Extra information on the teaching methods

In the plenary sessions and exercises students learn to differentiate between Standard (Belgian/Dutch) Dutch. This will contribute to the professional character of their own texts (spoken/written), and enables them to evaluate and edit texts from others.

By focussing on the pluricentric character of Dutch and on the stylistic variation in Dutch, students learn that norms in language matters are relative in space and time, that they are context sensitive, and that the difference between good/bad language is to a certain degree a construction of the mind.

## Extra information on the examination methods

During the final exam students are tested on the degree in which they can show a sufficient mastery of the Dutch language. They have to "correct" a text, i.e. indicate and replace what is wrong according to the norms of standard Belgian/Dutch Dutch, and thereby differentiating between what is really wrong and what is mere stylistic idiomaticity of the author.
